### Medical:

A number of physical and mental conditions are contraindications for participation in an Psilohuasca ceremony. It is vital for us to know if you are using medication, as some medications cannot be taken in combination with Psilohuasca.

It is possible that a consultation is requested with the apothecary or doctor, to see if the medication can be used with the MAO inhibitors. If your medications change after you've filled in this report, we would like to know as soon as possible, as long as it is *before* the Psilohuasca ceremony.
